**Concept note:** The Pacific Alliance is an initiative of regional integration comprised by Chile, Colombia, Mexico and Peru, established on 2011. The four economies combined represent the 8<sup>th</sup> largest GDP and the 8<sup>th</sup> export force worldwide.

During the **PABF**, representatives from these four member States will present the most recent developments and achievements of the Pacific Alliance, highlighting its enormous opportunities and business potential, particularly on the fields of Green Tech, Innovation and Public Investment, areas aiming to the fulfillment of the Sustainable Development Goals with gender perspective.

A roundtable for one-to-one meetings with specialist representatives from the PA member countries will be held previous to a 2 hours seminar in which, in addition to member States, entrepreneurs and representatives from three Alliance's observer States: Austria, Slovakia and Slovenia, will present their views, priorities and experience towards the Pacific Alliance.


